Overview. Primary Company and each Participating Client agree to all terms contained in this Addendum, and intend for the Authorized Individuals to have access to the Account(s).

Background. Primary Company and the Participating Clients have common ownership and management, and desire that the Bank allow the Authorized Individuals to access and transact business on each of the Accounts, in accordance with the Amegy Bank Business Internet Banking Agreement, including without limitation the ability to transfer funds between Accounts belonging to different Clients. The Amegy Bank Business Internet Banking Agreement, previously acknowledged, agreed to, and received by Primary Client, is made a part hereof and incorporated herein.

Client Acknowledgements. Primary Company and each of the Participating Clients certify that they have read and agree to the terms of this Addendum, and the Business Internet Banking Agreement, and further acknowledge:

- (a) each Participating Client is allowing funds transfers between its Account(s) listed below and
 - (i) Accounts of the Primary Company and other Participating Client(s) (if any),
 - (ii) accounts of other Participating Clients subsequently added by the Primary Company,
 - (iii) personal accounts added by the Primary Company;
- (b) the Primary Company may add additional Participating Clients to this Multiple Party arrangement without the knowledge or consent of any other Participating Client;
- (c) the Primary Company may add additional Authorized Individuals, who may or may not be signers on the Participating Client's Account(s), so that funds transfers to or from the Participating Client's Account(s) could possibly be done by individuals who are not signers on the Participating Client's Account(s);
- (d) funds may be transferred from the Participating Client's Account(s) to the Account(s) of other Clients, and may not be available to the Participating Client;
- (e) each Client shall have the sole responsibility to:
 - (i) determine the propriety of participating in this Multiple Party arrangement, including the Primary Company's authority to allow the participation of additional Participating Clients,
 - (ii) obtain from the Primary Company a list of all other Clients participating in this arrangement, together with such information concerning such other Clients as the Participating Client deems necessary, and
 - (iii) establish and maintain appropriate procedures to account for its funds.

A Participating Client may be removed from this arrangement, by action of (a) such Participating Client, (b) the Primary Company, or (c) the Bank. Each Participating Client hereby approves of the addition or removal, at any time, of other Clients as provided herein, without notice to or further consent of such Participating Client.

Indemnification. The Clients, jointly and severally, shall indemnify, defend and hold harmless Bank, its affiliates and their respective directors, officers, employees and agents from and against any and all claims, demands, damages, losses, liabilities, causes of action, costs, and expenses (including without limitation attorney fees and costs of court) arising out of or in connection with this Addendum, except to the extent that they arise from the gross negligence or willful misconduct of the Bank.

Authorized Signer(s). The individual executing this Addendum below represents, warrants and certifies to the Bank that he or she (a) is an authorized signer for the Primary Company and each of the Participating Clients listed above, and (b) has full authority to bind the Primary Company and such Participating Clients to the terms of this Addendum, and (c) acknowledges and agrees that the Amegy Bank Business Internet Banking Agreement, as it may be amended from time to time, is made a part hereof and incorporated herein.

Definitions

Accounts: all deposit accounts of the Primary Company, and the deposit accounts of the Participating Clients identified in the table above or in any other Addendum.

Addendum: this Online Banking – Multiple Party Addendum, and any similar addendum executed by Primary Company adding Participating Clients to this Multiple Party arrangement.

Authorized Individual: An individual authorized by Primary Company to transact banking business on any of Primary Company’s Accounts through Amegy Bank Small Business Online Banking.

Bank: Amegy Bank N.A.

Clients: Primary Company and the Participating Clients.

Participating Client: each of the entities identified as a Participating Client in the table above, or in any other Addendum by which Primary Company adds Participating Clients to this Multiple Party arrangement.

Primary Company: the entity identified as the Primary Company at the top of this Addendum.
